I, E. GARY GYGAX, of Lake Geneva, Wisconsin, hereby revoke my former wills and declare this to be my last Will.

ONE


I direct my Personal Representative to pay the expenses of my last illness, funeral expenses, and expenses of administration out of my Estate, whether or not such expenses are attributable to property included in my probate Estate.

TWO

All of the property which I own at my death is hereby given to my wife, GAIL CARPENTER GYGAX, of Lake Geneva, Wisconsin, if she survives me. It is my intention to exclude all of my children under the terms of this Paragraph whether born before or after this Will is executed.

THREE

If my wife, GAIL CARPENTER GYGAX, predeceases me, or if she does not survive me by five (5) months, all of my property is hereby given in equal shares to my children who survive me.


E. GARY GYGAX

If any child of mine predeceases me, the interest which would have passed to him/her had he/she survived me is hereby given by right of representation to the descendants of said deceased child who shall survive me. If any child of mine predeceases me and leaves no descendants surviving, the interest which would have passed to him/her had he/she survived me is hereby given in such shares and to such beneficiaries as would have been the distribution under this Will if that child had never lived.


FOUR

If any beneficiary dies prior to the entry of an order, decree, or judgment in my Estate distributing the property in question, or within five (5) months after the date of my death, whichever is earlier, any interest which would have passed to said beneficiary under other provisions of this Will is to be disposed of according to the plan of distribution which would have been effective under this Will if such beneficiary had predeceased me. It is my intention that any property or interest which is distributed from my Estate as a result of any court order, decree, or judgment will not be revoked or otherwise affected by the subsequent death of the distributee.

FIVE

A. Personal Representative.

I appoint my wife, GAIL CARPENTER GYGAX, as Personal

E. GARY GYGAX

Representative of my Estate. If, for any reason, she does not act as Personal Representative, I appoint my sister-in-law, DIANNE CARPENTER of San Dimas, California as Personal Representative of my Estate.

B. Bond.

My Personal Representative shall not be required to give bond, surety or other security.

C. Powers.


My Personal Representative shall have power, without court order, to settle my Estate as this Will provides and to do all my Personal Representative deems necessary or desirable to administer my Estate, including the following:

(1) to distribute principal and income on an interim basis to those entitled to it;

(2) to sell, lease, exchange, mortgage, pledge or assign all or part of my Estate's property, whether or not necessary, to pay debts, taxes or administration expenses;

(3) to invest and reinvest property not specifically given; and

(4) to continue to operate any business or business properties in which I have an interest at my death, and, in so doing, delegate powers.




D. Taxes.

My Personal Representative shall pay from the residue of my Estate all death taxes imposed because of my death and interest and penalties on those taxes, whether on property passing under this Will or otherwise.
